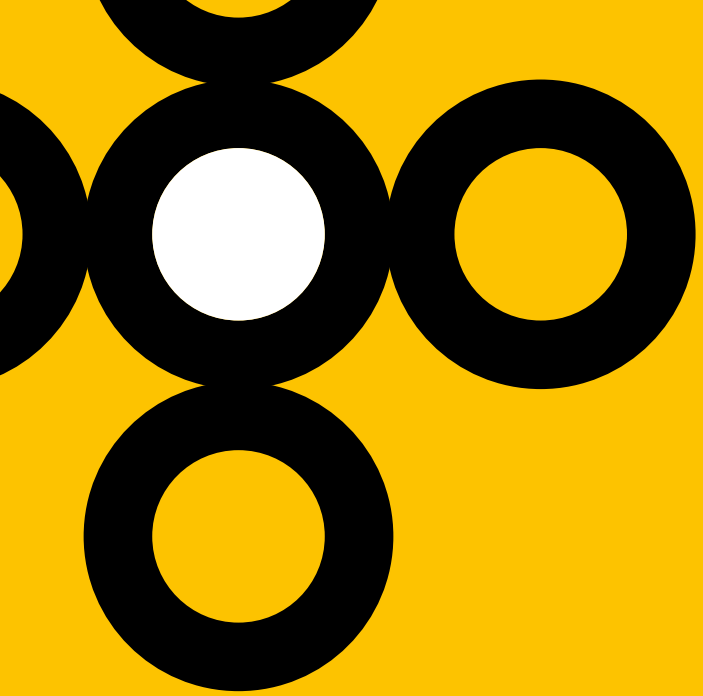

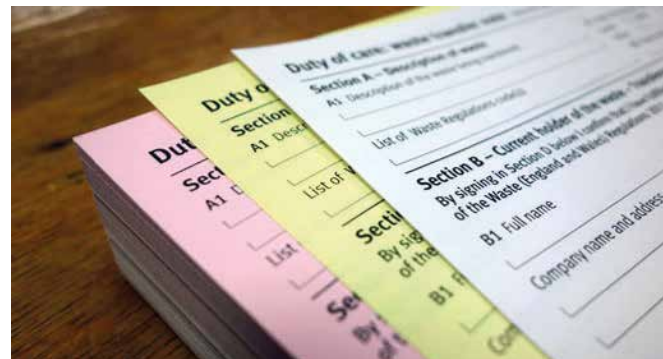

HAZARDOUS WASTE REGULATIONS – LET EDGE TAKE THE STRAIN

Duty of Care – How Edge Takes Away The Worry

The Duty of Care is a law which says that you must take all reasonable steps to keep waste safe. If you give waste to someone else, you must be sure they are authorised to take it and can transport, recycle or dispose of it safely.

Duty of Care applies to anyone who produces or imports, keeps or stores, transports, treats or disposes of waste. Breach of the Duty of Care is an offence, with a penalty of up to £5,000 on summary conviction or an unlimited fine on conviction on indictment.

Under the Duty of Care Regulations 1991 (the 1991 Regulations), parties transferring waste are required to complete and retain a “transfer note”, containing a written description of that waste. Defra has provided statutory guidance on the completion of the duty of care transfer note in.

Hazardous waste is essentially waste that contains hazardous properties that may render it harmful to human health or the environment. Many everyday products such as fluorescent tubes, TVs, computer monitors and some paints and batteries are now classed as hazardous waste. (Please visit www.environment-agency.gov.uk for a full listing of hazardous waste substances).



If you produce any of these hazardous substances you may need to register your premises with the Environment Agency on an annual basis. The Environment Agency charges a fee to register your premises with them. Skippy Nationwide can assist you with registering your premises if required.

There are some exemptions in place so not everyone need register their premises:

People who **do** need to register their premises:

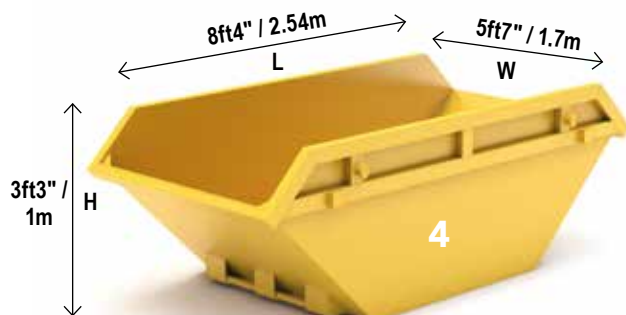
- Businesses producing any hazardous waste.
- Any households, offices, shops, farms, schools, colleges, prisons, residential and nursing homes, hospitals, dental, veterinary and other medical practices, premises used by charities and places used for the purpose of collecting waste electrical and electronic equipment that produce more than 500Kg of hazardous waste in a year.

Skip Essential Don'ts

- ⊗ Don't overfill the skip. This is dangerous and in some cases, makes it impossible for it to be lifted.
- ⊗ Don't have fires in the skips. This is illegal and you will be liable for replacement or repair costs.
- ⊗ Don't mix hazardous waste in with inert or general waste as this will incur additional costs and may mean we are unable to take your waste away.



MINI SKIP (4 CUBIC YARDS)

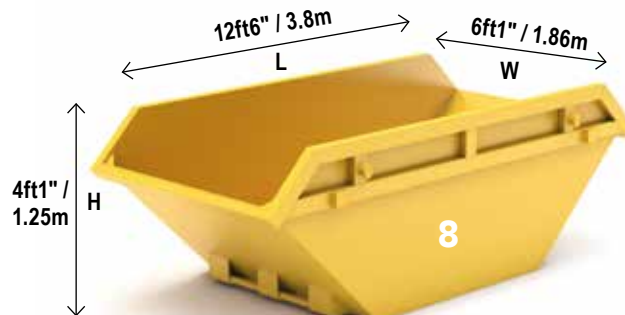

MINI SKIP (8 CUBIC YARDS)

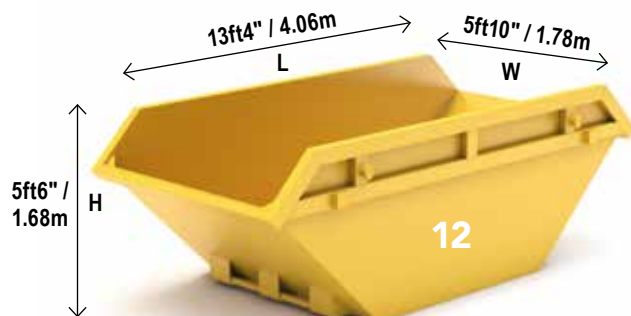
